- Approve appointed Secretariat members (Time: 5 Min ) Jim
  - Carol Nelson motioned and Dennis Smith 2<sup>nd</sup> the motion, passed.
- Approve November Minutes (Time: 5 Min ) Jim
  - Motioned by Carol Nelson and Jenny Torres 2<sup>nd</sup> the motion, passed.
- Mike Withrow letter read regarding reason needing to step down as Weekend Leader.
  - Opened floor to discuss possible replacements.
  - Dave Small suggested those that head up early create a team for upcoming weekend till position is filled to cover needs.
- Weekend Fee Discussion (Time: 10 Min ) Mike/Jim
  - Proposed \$10 increase in team/Pilgrim fees due to camp fee increase.
